



Tips for Submitting Effective Comments

Submitting comments via the Federal eRulemaking Portal at www.regulations.gov is an easy and effective way to provide constructive, reasoned, and evidence-based guidance to improve federal regulations and policymaking. What You Need to Know

The Office of Federal Strategy is available to support regulatory engagement and can provide:

- In-depth political analysis and context for the proposal
 - Guidance related to internal approval processes, if needed
 - Awareness of positioning of other Hopkins divisions/centers/units
 - Protocol advice related to tone, formatting, and style
- Tips for addressing trade-offs and opposing views in your comment
 - Connections to national trade and professional associations and other stakeholder groups, if appropriate
 - Support in determining who should sign and who should be alerted internally for situational awareness
 - Complementary methods of providing feedback, including in-person meetings
 - Access to archived Johns Hopkins comments and historical engagement on the issue

Comment Letter Tips

1. Identify the rule you are commenting on and provide the Regulation Identifier Number (RIN), plus any word, column, or paragraph citation from the federal register document to clearly identify the issues or parts of the proposed regulation on which you are responding.

2. Be constructive and offer an alternative or modified approach to meeting the same objective or, if you disagree with the action, suggest not regulating at all.

3. Use data and evidence to support your argument, including relevant personal or professional experience, if appropriate.

4. Avoid jargon and acronyms; use plain language and headings to group information into meaningful chunks.

5. Use the disclaimer *"The views expressed are my own and do not necessarily reflect the views or positions of the Johns Hopkins University or the Johns Hopkins Health System"* in your comment letter and remove any logos because you are commenting as a subject matter expert, not on behalf of your employer.

6. Distinguish your comment from others by identifying your credentials and expertise—avoid form letters.

7. Know your audience and demonstrate the ways in which your recommendation reflects the best interests of the federal government and federal taxpayers.

8. Be aware of deadline; you have until 11:59 p.m. Eastern time that day to submit your comment.

9. Timely comments become a matter of public record. The comment, attachments, and supporting materials will be posted without change to Regulations.gov, including any personal information provided.
